Changes on Ag Hill

The last three years has seen a lot of changes on Ag Hill. First Brother Chuck Strauss retired as Director of the School of Forest Resources and was replaced by Mike Messina, an SFR graduate who was an associate unit leader at Texas A&M. Then long-term Dean Bob Steele stepped down and was replaced by Bruce McPheron, Associate Dean for Research in the College of Agricultural Sciences. These changes were just the beginning of a triple whammy to Ag Hill because of severe budget limitations and directives from Old Main. The College faced significant economic challenges from eroding state appropriations that have not kept pace with increasing costs such as health care and skyrocketing state pension obligations. A downsizing within the College in 2010 resulted in ten people losing their jobs and dozens of additional positions being eliminated through attrition (including two within the School). The downsizing was across the college's education, research and cooperative-extension missions, but it virtually eliminated the opportunity for Director Messina to hire any new

faculty and otherwise put his personal stamp on the faculty and School.

The next hit was a directive from Old Main to restructure the college by reducing the number of academic units from 12 to "six or so." To address the economic challenges and Old Main's directive, the College worked through an AG Futures process to identify areas of strategic innovation and growth. The intent was to challenge assumptions about "what we do" and "how we do it" to determine the best application of scarce resources to achieve the College's vision. This process utilized six teams, consisting largely of college faculty, to address the consolidation of academic units. The six teams were charged with reviewing the existing academic units and making recommendations for academic restructuring.

The School of Forest Resources fared reasonably well in this process. All six teams recommended that Forest Science and Wildlife and Fisheries Science stay together. The teams also recommended that the Environmental Resources Management undergraduate program be in the same school or department. Most of the teams recommended that the Wood Products major be an option under Forest Science because it did not have an adequate enrollment to sustain it as an undergraduate major. The six names proposed for the School were Ecosystems and Natural Resources; Environment, Natural Resources and Ecosystems Sciences; Natural

The Brothers of Tau Phi Delta convened a Grand National Convention on April 25, 2009, to approve the articles of incorporation and bylaws of the Tau Phi Delta Foundation. The Foundation is a Non-Profit Corporation formed under the Non-Profit Corporation Law of the Commonwealth of Pennsylvania.

It is organized exclusively for charitable, educational and scientific purposes, including for the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. The Foundation is specifically structured to provide and enhance educational opportunities for active student members and alumni of Tau Phi Delta affiliated with the Tau Phi Delta Grand National Chapter, a section 501(c)(7) organization.

The Foundation is managed by a Board of Trustees elected from the fraternal alumni members of Tau Phi Delta. The Trustees work diligently to develop plans for accepting contributions and managing revenues to support the purposes of the Foundation.

Resources & Ecosystem Science & Management; Ecosystems Science, Conservation and Management; Department of Natural Resources; and Forest Ecosystems. Unfortunately, only one team recognized the importance of forestry at the "University of Penn's Woods."

The third whammy was the proposed cut to Penn State in 2012 by Governor Corbett. His original proposal was a 52.4 percent cut; the final appropriation resulted in a 19.6 percent cut. This cut required the Dean to offer an early retirement package to 120 faculty, staff and extension agents. Eighty employees accepted the package. The School's WFS major was especially hit by the cuts. Three of the seven WFS faculty accepted the package (Tzilkowski, Yahner, San Julian) and another accepted a position at another university (Carrick), leaving three faculty members to support the WFS major (Brittingham, Ferreri, Stauffer). The water option within the Forest Science major also suffered when only one of the three faculty members retiring in the past four years was replaced. Wood Products will be an option of Forest Science, however, two Wood Products faculty members have opted to move to the Department of Agricultural and Biological Engineering.

The Dean's final proposal to Old Main and the Board of Trustees is to reduce the number of academic units from 12 to 9. Forest Science, Wildlife and Fisheries, and Crop and Soil Science are to be merged into a new Ecosystem Science and Management department. This name was recommended by the faculty, not the alumni and friends of the School. Poultry and Dairy are to be merged into Animal Science, and the remainder of Crop and Soils, plus Horticulture are to be combined as a Plant Science department. The rest of the original units are pretty much intact even though a merger of Plant Pathology and Entomology was on the table for a few years and recommended by the faculty teams. Is this a surprise, given that the Dean is an Entomologist?

The bottom line is that the past two years have been a complete disaster for the School of Forest Resources. After 100+ years, the School lost its name, and has either lost or will lose sixteen vital faculty responsible to key majors and options. These faculty will not be replaced in the foreseeable future.
